RESOLUTION NO. 2020-60

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELL GARDENS, CALIFORNIA, APPROVING AN AGREEMENT BETWEEN THE CITY OF BELL GARDENS AND FOLSOM LAKE FORD FOR THE PURCHASE OF ONE (1) PATROL VEHICLE AND EQUIPMENT REPLACEMENT

WHEREAS, the Bell Gardens Police Department utilizes marked black and white vehicles to perform patrol operations throughout the City of Bell Gardens; and

WHEREAS, after a thorough analysis of the fleet, staff recognized the need to replace one (1) patrol vehicle to maintain reliability and safety of the fleet; and

WHEREAS, the police department re-evaluated its fleet during the previous budget year and was authorized by City Council to purchase the Ford Police Interceptor Utility vehicle for use by patrol personnel; and

WHEREAS, pursuant to Section 3.04.100(E) of the Bell Gardens Municipal Code (BGMC), formal bidding is not required when supplies, services or equipment can be produced from a supplier who offers the same or better price, terms and/or conditions as the supplier previously offered as the lowest responsible bidder under competitive procurement conducted by another city or public agency; provided, that the competitive procurement process of the other agency meets or exceeds the standards of the city, is for like or greater quantities, includes all known bidders and that, in the opinion of the Purchasing Officer, it is in the best interest of the city; and

WHEREAS, the California Highway Patrol issued an Invitation for Bids for a procurement contract for utility pursuit police vehicles; and

WHEREAS, the California Highway Patrol awarded the procurement agreement to Folsom Lake Ford; and

WHEREAS, staff obtained pricing from Folsom Lake Ford for the purchase of one (1) Ford Police Interceptor Utility vehicle utilizing a procurement; and

WHEREAS, the police department is requesting City Council to approve an appropriation for FY2020-21 of Thirty-Nine Thousand Two Hundred-Fifty Dollars and Forty-Three Cents (\$39,250.43) in the Asset Forfeiture fund for the purchase of one (1) new Ford Police Interceptor Utility vehicle.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Bell Gardens as follows:

<u>SECTION 1.</u> The City Council, after consideration of the staff report and presentation, discussion, oral testimony and evidence presented to the City Council,

hereby finds that the above recitals are true and correct and incorporate them herein.

SECTION 2. The City Council approves the Agreement and authorizes and directs the City Manager to execute the Agreement attached to the Staff Report as Exhibit 2.

SECTION 3. The City Council further authorizes and directs the City Manager and staff to take all actions necessary and appropriate to implement and effectuate the intent of the City Council as set forth in this Resolution.

SECTION 4. Subject to all applicable laws, the City Council hereby authorizes the City Manager to execute any ancillary documents relating to the Agreement, including any amendments, extensions, and other documents consistent with the Agreement and this Resolution

SECTION 5. The City Clerk shall attest and certify to the passage and adoption of this Resolution and enter it into the book of original resolutions, and it shall become effective immediately upon approval.
